## *From the President.*

Dear Friends and fellow GDCA members;

The BOD voted unanimously to change the Top 20 rules in several areas. For some time the issue of whether or not to allow the results of the judging to be known has been discussed widely. You will all recall each judge must score each dog in a number of areas for a maximum total of 100 points. There are

three judges so the maximum score possible would be 300. At the conclusion of the awards dinner each owner will be given the scores which will be written on the dog's armband. The scores will be the aggregate of all three judges. The judges will not be identified. What the owner does with that information is up to them. Arm bands will be numbered randomly and published in the Top Twenty catalog. Each dogs name will be placed on the back of the armband. The announcement will be made by the top 20 Chair and in the case of a tie there will be two winners.

Several issues ago I wrote to you about the Charitable Trust funding the sequencing of the Great Dane genome. That contract has been signed. In addition to sequencing the Great Dane Genome, Dr.

Clark and her team will be looking for candidate genes that may cause Dilated Cardio Myopathy. Dr. Clark will be Collaborating with Dr. Kate Meurs and Dr. Mark Oyama . This project has the potential to do more for our breed than anything we have done to date. This work will aide researchers looking for genetic markers for any variety of diseases and because this information will exist more research work will be done for our breed.

We also voted to fund a Wobblers research project which is being conducted by Dr. La Costa at Ohio State. This project could result in a test regimen that is considerably less expensive than what is currently being used and eliminates the pain associated with the current method. If successful this test regimen could be used to identify Wobblers very early on. We need your help to continue to fund this kind of work. If all of our members would contribute just an additional \$10.00 this year to the Charitable Trust 80% of the cost of these projects would be covered.

The central mission of the GDCA is the betterment of our breed. Predicting illness through genetic testing will help with breeding decisions and help reduce the occurrence of those diseases which are passed on genetically. Gene based therapies may one day cure diseases that take our Danes from us too soon. Down the road, just maybe Great Danes that live thirteen healthy years can be the norm not the exception. We can make the difference!

Three digit armband numbers will be generated by a random number generator and will be published in the Top 20 catalog.

**Top 20 Statistician will place each dog's name on the back of the armband before it is sent to the Top 20 Division Chair so it is ready for the night of the**

competition. At the conclusion of the competition, the stewards will collect the armbands to give to the accountant to prepare the composite score, put it in sealed envelopes and have ready for the individual owners at the awards banquet. The accountant will put each dog's name on the outside of its envelope. If the accountant is present at the awards banquet, he or the Top 20 Chairman will give them out to the owners, upon request only and those not picked up would go back with the accountant to be destroyed along with the score sheets.

In the instance of a tie, there will be two Top 20 winners. Top 20 entry form will be placed on the GDCA website in case the physical packet is lost in the mail. The packets will no longer be sent certified. After packets are mailed, a follow up email will be sent to the owners to ensure the packet is received.
